- The sewers on Bayless still need to be ground down to allow more water flow when it rains. Homes and businesses are being flooded during heavy rains.

HEALTH AND SANITATION - Alice Lotspeich

Alderman Sikorski asked if tall grass and weeds are being addressed.

BUILDING: John Franklin

 Alderman Lotspeich asked when Dallas potholes will be repaired. Mayor Puleo stated we have still not received any response to our bid requests. There are some potholes in the City that are too large for Commissioner Reed to fill.

WARD TWO: ALDERMAN SHARP and ALDERMAN HANSEN

Alderman Sikorski heard other Municipalities are issuing tickets for expired license plates. She asked why the City still has so many vehicles with expired plates parked on the City's streets. Chief Brackett replied they can only issue one ticket per day per vehicle.

WARD THREE: ALDERMAN DUNN and ALDERMAN SIKORSKI

Nothing to report.

UNFINISHED BUSINESS

- No additional bids were received for pothole repair.
- Discussion was had regarding the bids received for the replacement of the City Hall front porch. Alderman Hanson feels the porch should be repaired versus replaced. He is going to look into pricing for this. Alderman Sikorski feels the entire porch needs to be replaced because the ramp is too steep for safe wheelchair usage and the steps are a trip hazard.

RESIDENT/PUBLIC PARTICIPATION (two minutes each)

- Resident Regina Pensin has several concerns:
 - She is concerned a resident on Ruprecht may be dangerous due to mental health issues.
 - There are several derelict vehicles and vehicles with expired plates in the City.
 - There are weeds blocking access in the alleys.
 - A rental property on Ruprecht doesn't regularly cut their grass.
 - A residence on Ruprecht looks like a "junk yard" with multiple derelicts vehicles. The resident blocks her garage while working on cars.
 - Mayor Puleo asked Chief Brackett to start issuing citations for derelict vehicles and expired plates in the City. Chief Brackett said he has a contact in the Department of Revenue that has opened a case to investigate cars with dealer plates.
- Jennifer Wagner said the potholes on Dallas are just getting bigger. Can the City
 use tax receipts for the repairs? Mayor Puleo said a tax levy cannot be put on the
 ballot until November 2024. Alderman Hansen would like to expedite pothole bid
 acceptance if any are received.
- A resident asked if everyone has received an email from Missouri American Water asking residents to self-report if they have lead pipes. Mayor Puleo will forward the request to anyone that needs it.
